History of the EBA, in parts

EBA Newsletter Number 3, January 1983

In Newsletter 3 it was realized that the creation of a European Bonsai Association is somewhat more difficult than anticipated. Not only the funding was not easy, the large distances between the countries would have to be overcome and the preliminary statutes needed some revision. (look at page 12)

There was little correspondence between the bonsai clubs and the coordinator Marc De Beule mostly in connection with the meeting in Valencia; only 4 clubs were able to come. At the Valencia Meeting the today's name of the organization, "EBA" instead of "FEBA" has been finally established and some changes to the statutes were made.
(look at page 13+14)

The publication of an own bonsai magazine was considered to be impractical and it held on to the publication of the newsletter (NL).
(look at page 15)

In the NL 3 was also published the invitation to the British Bonsai Convention in Keele and it was asked for more information about bonsai clubs in some selected European countries. On page 17 a document containing the tasks of F(o)BBS is copied. It already has historic value.

The NL 4 of the EBA will be presented in the next newsletter. All pages of the EBA NL3 can be requested from the Secretary as a pdf.file.

6. VALENCIA : REPORT

Art. I - The preferred name is "EUROPEAN BONSAI ASSOCIATIONS" (E.B.A.). We all felt E.B.A. was nicer than F.E.B.A. and thought that the word FEDERATION could be substituted by the plural "ASSOCIATIONS", having the singular meaning.

Art.II - Where it says....."the Board of Directors.....", should say "..... the Committee....."

Art.III- Germany, England and Spain were against the existence of individual members of E.B.A. in countries with Clubs or National Associations

to add:

i) To promote friendship between all the Bonsai lovers of the world.

Art. V- The formula for calculation of annual membership proposed in the by-laws was not considered correct, because the membership fee of the various clubs or nat. ass. could be very different. Therefore their contribution per capita to E.B.A. would be different as well, although they all would have the same benefits from E.B.A.

It was thought more convenient to say that the annual membership fee will be an amount per ordinary member of the club or association, equal for all the clubs and will be determined by the Committee every year, according to the activities and need of E.B.A.

Art. VI- Sec. 1.

b) Where it says "Every association shall appoint one delegate", we should add "with a maximum of three per nation. Should there be more than three clubs in the nation, three representative delegates should be chosen between all of them". If we do not decide it this way, the nations without a National Association have the -- enormous advantage of having an unlimited number of delegates in the committee, (one per club) against the National Associations, which will only have three delegates.

EBA HISTORY -PART III

We considered that if amendments had to be accepted by the R.G.M. of all the membership, the host country of the R.G.M. would always have a majority of voting members present. Although the members of other countries may use the mail-vote, it is never widely used. We feel that if these matters are decided by the committee Officers, all countries would have a more equal chance of vote. And anyways, if we are good enough to write and accept these by-laws, why shouldn't we be good enough to change them?.

SUGGESTION FOR A MAGAZINE

We propose: No E.B.A. magazine is practicable.

A) General remarks

1) To publish a European News-letter, 4 times a year and stimulate the exchange of magazines among member associations.

2) One Bonsai Magazine for every language area of Europe. All articles of any Bonsai Magazines in Europe can be -- freely translate and published in any of the other European Bonsai magazines, with a mention of its origin.

3) E.B.A. should create a "pool of literary material", with all sorts of articles from E.B.A. members and others, from where all member clubs and National Associations could obtain materials for their magazines or newsletters. To encourage sending articles, E.B.A. could give a price for "The best article of the year".

B) Accept English as the official language.

C) 4 issues per year (for the Newsletter)

D) All the contents you proposed should be included in the Newsletter, adding the articles received for the "pool of literary material".

All the "Possible projects to be organized by E.B.A. were thought to be useful.

All the abovementions corrections and propositions were accepted by the delegates of the four nations present in Valencia (Spain), on the meeting held on the afternoon of the 13rd November 1982 at Iberflora 82. It was agreed that I would communicate you all these agreements in the name of the four.
